### **Information pursuant to art. 13 of European Regulation 679/2016 and consent**

Pursuant to art. 13 of European Regulation (EU) 2016/679 (hereinafter GDPR), and in relation to the personal data that the firm will have access to with the assignment of your practice, we inform you of the following:

#### **Data Controller and Data Protection Officer**

The Data Controller is Il Bel San Michele O.d.V. (hereinafter referred to as "IBSM") in the person of the President p.t. Vittorio Vaccari with domicile in Pavia (PV) piazzetta Azzani n.2. #### **Purpose of data processing**

The processing is aimed at the correct and complete execution of what is required for participation in the competition announced on 25 November 2024 by IBSM.

Personal data may be processed using both paper and electronic archives (including portable devices) and processed in ways that are strictly necessary to meet the purposes indicated above.

#### **Legal basis for processing**

IBSM processes your personal data lawfully, where processing is necessary for the performance of the competition activities for which you have applied.

#### **Consequences of failure to communicate personal data**

Regarding personal data relating to participation in the competition announcement for which you have applied, failure to communicate personal data prevents the completion of the relationship between the parties.

#### **Data storage**

Your personal data, processed for the purposes indicated above, will be stored for the duration of the competition (from the submission of the application to the publication of the results) and, subsequently, for the time in which IBSM is subject to storage obligations for tax purposes or for other purposes, provided for by law or regulations.

#### **Data Communication**

Your personal data may be communicated to subjects who process data in compliance with specific legal obligations.

#### **Profiling and Dissemination of data**

Your personal data is not subject to dissemination or to any fully automated decision-making process, including profiling.

#### **Rights of the interested party**

The rights granted to you by the GDPR include those of:

- asking the Association for access to your personal data and information relating to them; the rectification of inaccurate data or the integration of incomplete data; the deletion of personal data concerning you (if one of the conditions indicated in art. 17, paragraph 1 of the GDPR occurs and in compliance with the exceptions provided for in paragraph 3 of the same article); the limitation of the processing of your personal data (if one of the hypotheses indicated in art. 18, paragraph 1 of the GDPR occurs);
- requesting and obtaining from the Association - in cases where the legal basis of the processing is the contract or consent, and the same is carried out by automated means - your personal data in a structured and machine-readable format, also for the purpose of communicating such data to another data controller (so-called right to portability of personal data).
- objecting at any time to the processing of your personal data in the event of situations concerning you.
- withdraw consent at any time, limited to cases in which the processing is based on your consent for one or more specific purposes and concerns common personal data (for example, date and place of birth or place of residence), or particular categories of data (for example, data revealing your racial origin, your political opinions, your religious beliefs, your state of health or sexual life). The processing based on consent and carried out prior to its withdrawal, however, retains its lawfulness.
- lodge a complaint with a supervisory authority (Italian Data Protection Authority – [www.garanteprivacy.it](http://www.garanteprivacy.it)).
